Agenda No. 1:- Confirmation of Minutes of the meeting held on 21.02.2019
The Minutes of the 12th Meeting held on 21.02.2019 were confirmed.

Agenda Item No.02: Application of M/s. Barclays Global Service Centre Pvt. Ltd. for Cafeteria, Crèche, Gymnasium under processing area of KRC infrastructure and Projects Pvt. Ltd. and Gera Developments Pvt. Ltd. - SEZ.


Unit's representative explained that establishing the cafeteria, crèche and gymnasium is the requirement for the benefit of the employees who will be working day and night. Since they are occupying nearly 10 lakhs sq. ft. area and nearly 10000 persons will be employed, they wanted a world class facility for them.

After deliberation, Committee approved the request of the unit for cafeteria facility subject to the following conditions: -

1. Service provider would not avail any indirect and Direct Tax Benefit available under the SEZ Scheme.
2. Unit/ Service provider shall adhere all the statutory compliances such as fire NOC, PHO NOC etc.

Committee further observed that the other two facilities (gymnasium and crèche) comes under the authorized operation of Developer/Co-Developer in terms of Rule 11(5) of the SEZ Rules, 2006. Unit's representatives requested the UAC to forward the proposal to Ministry for favorable consideration as it is a welfare measure for the benefit of employees working in the SEZ unit. Committee also felt that the request of the unit for setting up Creche and Gymnasium is a facility which is required by the employees working in the SEZ. Since Rule 11(5) of SEZ Rule doesn't give mandate to the unit to set up such facility by their own, Committed decided that matter may be referred to Ministry for consideration.

Meeting ended with a vote of thanks to the Chair.
