As directed the subject unit has also submitted additional Bond of Rs 20 Cr Value, hence covering the three month leviable cumulative duty, however, the Specified Officer has not confirmed about the NFE and details of exports & Imports of the unit & asked as to whether the unit has achieved positive or negative for the period of 2017-18, hence monitoring not done.
