

Arshiya Limited has submitted letter dated 25.10.2017 on the issue which was placed for consideration & deliberation by UAC.

After discussion, committee was of the view that the matter may be referred to MOC&I for necessary clarification and final view in the matter may be taken accordingly. Also the practice being followed by FTWZ in other zones, may also be confirmed w.r.t. approval of List of items for FTWZ units.
