Agenda Item No. 1: Confirmation of Minutes of the 131st meeting held on 28.10.2021.

The Minutes of the 131st Meeting held on 28.10.2021 were confirmed with consensus.

**Agenda Item No. 02: Monitoring of Performance of the unit M/s. Srikaram
Prescience Pvt. Ltd -reg.**

The Annual Performance Report for a period of 4 years i.e. 2016-17 to 2019-20 was submitted by the unit and verified by the Specified Officer, Arshiya-FTWZ vide letter dated 28.10.2021. The unit has achieved positive NFE of Rs. 449.55 Lakhs on cumulative basis as per S.O.'s verification report.

Decision: - After deliberation the Committee **noted** the performance of M/s. Srikaram Prescience Pvt. Ltd at Arshiya Limited - FTWZ for a period of 4 years i.e. 2016-17 to 2019-20 in terms of Rule 54 of SEZ Rules, 2006.

**Agenda Item No. 03: Monitoring of Performance of the unit M/s. Jabs
International Pvt. Ltd -reg.**

The Annual Performance Report for a period of 5 years i.e. 2016-17 to 2020-21 was submitted by the unit and verified by the Specified Officer, Arshiya-FTWZ vide letter dated 01.11.2021. The unit has achieved positive NFE of Rs. 1103.00 Lakhs on cumulative basis as per S.O.'s verification report.

Decision: - After deliberation the Committee **noted** the performance of M/s. Jabs International Pvt. Ltd at Arshiya Limited - FTWZ for a period of 5 years i.e. 2016-17 to 2020-21 in terms of Rule 54 of SEZ Rules, 2006.

**Table Agenda Item No. 04: Proposal of M/s. Arshiya Panvel Logistics Services
Pvt. Ltd. for Broad Banding-Addition of Authorized
Operation Processing Services (Blending).**

M/s. Arshiya Panvel Logistics Services Pvt. Ltd has requested for Broad Banding-Addition of Authorized Operation Processing Services (Blending). The Unit justified that they intend to carry out authorized operation as per the Instruction no. 79 dt. 19.11.2013. The Unit representative requested to grant them permission for the authorized operation subject to State Excise approval.

Decision : After deliberation, the Committee noted that Specified Officer, Arshiya-FTWZ has informed that the process of blending is a manufacturing process in wine/liquor manufacturing industry. Thus it is a part of manufacturing activity so far as liquor/wine manufacturing industries are concerned for which a new Unit application is to be submitted. Also Specified Officer, Arshiya-FTWZ had mentioned that they have sought approval from State Excise Authorities and several reminders have been sent for which reply is awaited.

The Committee directed that since the process appeared to be as manufacturing and not covered under trading and service activity, views to be obtained from Ministry and also requested Specified Officer, Arshiya-FTWZ to obtain the approval from State Excise Authorities and also to submit their comments on the said activity.
