**Sub: Constitution of a Committee regarding examination of the cases of Removal of Scraps/E -waste of units under jurisdiction of DC SEEPZ-SEZ.**

The issue of disposal of scrap has been engaging the attention of this office amidst references/complaints being received on the subject, more specifically in the case of exiting IT/ITES units. Accordingly, a need has been felt to review the existing procedures for removal of scrap/e-waste from all SEZ units falling under the jurisdiction of Development Commissioner SEEPZ.

Accordingly, a Committee comprising of Shri Anil Chaudhary (S.O./SEEPZ-SEZ), Shri Durgesh Tiwari (S.O./Arshiya-FTWZ) and Shri B. Ajay Kumar (S.O./Pune-Cluster) is hereby constituted, and the mandate of the Committee shall be as follows:


- i. To study the existing procedure and if need be, suggest modifications so as to ensure a uniform policy/procedure regarding removal of Scrap/e-waste of units under jurisdiction of DC SEEPZ -SEZ, within the ambit of the SEZ Act and Rules, within a time frame of 15 working days. The procedure should cover the dismantling of goods, their classification as scrap, method/basis of valuation, manner of clearances from SEZ, duty applicability, and any other issue found to be relevant.
- ii. To revisit the cases involving removal of scrap from SEZ units from 01-01-2020 onwards, from the point of view of due compliance to the existing procedure in this regard, within a time frame of 60 working days.

It is also observed that one live case of exit of M/s Barclay, Quadron SEZ, Pune is under process wherein clearance of scrap has been undertaken. The Committee is to examine this matter. In order to avoid delay in decision making on the issue of exit of the unit, a report may be submitted within 3 days (unless some documents are required to be submitted by the unit). The Committee should examine this case in light of existing provisions, including P.N. 30/2016 on 09.12.2016 issued in SEEPZ and Rule 39 and Rule 49 of the SEZ Rules 2006 as relied upon by the unit and any other relevant SEZ Rule.
