**Agenda Item No. 01:- Application received for Setting up a new unit under
the EOU Scheme - M/s. Bliss GVS Pharma Ltd..**

The Committee noted that the proposal is for setting up a new unit under
the EOU Scheme for manufacturing and export of Pharma & Health Care
Products:- (1) Tablets (2) Dry Syrups (3) Capsules (4) Pessaries (5)
Suppositories. FOB value of export of Rs. 44088.44/- lakhs, NFE of Rs.
23877.43/- Lakhs, Investment in Plant & Machinery of Rs. 7167.59/- Lakhs
and employment of 70 persons.


Decision: After deliberation, the Committee approved the proposal of the unit for setting up a new EOU for manufacturing and export of Pharma & Health Care Products:- (1) Tablets (2) Dry Syrups (3) Capsules (4) Pessaries (5) Suppositories at Plot No. 1 to 3, Survey No.43(Part) & 44 (Part), Village Veroor, Nandora Road, Tal Palghar (E), Dist. Palghar in terms of Para 6.05 (a) and 6.06 of FTP 2015-2020 read with para 6.01 (b) of HBP.

Agenda Item No. 02:- Application received for Additional location, Enhancement in Capacity and Broadbanding of items(s) of manufacturing - M/s. Deccan Fine Chemicals (I) Pvt.Ltd.

The Committee observed the proposal of the EOU unit for addition of partial area of their DTA unit, Capacity enhancement of item (s) of manufacture and Broadbanding of item(s) of manufacture.

Decision :- After deliberation , the Committee observed the deficiency in project & directed the unit to submit the details of C.G , R.M, stock with depreciated value to be transferred to EOU, MPCB clearance , Industrial approval from concerned authority and also directed the Jurisdictional Central GST authority to inspect the premises and submit a detailed report regarding physical segregation from DTA unit along with demarcation plan, verification of stock of C.G, R.M along with depreciated value and also directed to regional DGFT to check the outstanding export obligation etc if, any pending against the unit . Accordingly the proposal was deferred for resubmission before the committee after the above compliances.
