Agenda Item No. 02:- Application for setting up of New Unit- M/s. Magnesia Chemicals LLP

The Committee noted the proposal for setting up of New Unit at GAT No. 81/A, Parhar Village Road, Lonand, A/P Koregaon, Phaltan, Satara-415523 for manufacture and export of "Potassium Permanganate" with export turnover of Rs. 10,033.20 Lakhs, NFE of Rs. 9,667.15 Lakhs, Investment in Plant & Machinery of Rs. 485.34 Lakhs and employment of 30 Nos. of persons.

During the meeting it is noticed that, the unit has submitted MPCB Certificate showing maximum capacity of Potassium Permanganate 2400 MT. The unit representative conveyed that they have obtained revised. MPCB certificate to operate with a capacity of 7800MT of Potassium Permanganate.
