**Sub: Compliance of the conditions as stipulated in the minutes of the meeting of the Board of Approval for SEZs.**

Attention is invited towards the general conditions laid down in minutes of the Board of Approval (BoA) meetings regarding the compliance of the agenda points.

It seems that the compliance has not been done by the Developers/Units as per the minutes of the BoA in some cases. Considering these facts, it is directed to all SEZ Developers/Units under the jurisdiction of Development Commissioner, SEEPZ-SEZ to comply with all the conditions stipulated in the minutes of the meeting of the Board of Approval for SEZs regarding the respective agenda points & to submit undertaking for compliance in this respect alongwith submission of acceptance letter.

The compliance documents need to be submitted to this office within 15 days of the compliance.

Further, all concerned S.Os are hereby directed to list out all the earlier cases & examine to confirm that the said conditions have been complied with by such Developers/Units. Also, they are hereby instructed to monitor this issue strictly and submit their self explanatory report with clear recommendations within 30 days that no compliance is pending at any SEZ/unit level.

In respect of future cases, all compliances as per BoA minutes will have to be done within 30 days of the receipt of the said minutes and a report to be submitted this office through respective S.O.

Failure of compliance of the above mentioned conditions may invite penal action in terms of FTDR Act, SEZ Act, 2005 and SEZ Rules, 2006.
