Agenda Item No. 02: Approval for Broad - Banding of items with Revision of Projections - M/s. Metro Global Business Services Pvt. Ltd.

After deliberation, the Committee approved the proposal of Broad - Banding of items vis. Information Technology Enabled Services - Data Entry Operation Services, Back Office Operations and Data Processing/Data Conversion, Computer Software Services, Support Centre Services and Remote Maintenance Services with Revision of Projections for the period of 3 years i.e. 2018-19 to 2020-21 with export performance of Rs. 36,848/- Lakhs and NFFE of Rs. 35,023/- Lakhs.

Agenda Item No. 03: Monitoring of Performance of the unit - M/s. Talent Anywhere Services Pvt. Ltd.

The Committee monitored the performance of M/s. Talent Anywhere Services Pvt. Ltd. in terms of Rule 54 of SEZ Rules, 2006 and noted that the unit has achieved positive NFE of Rs. 10,522/- Lakhs on cumulative basis during the period 2013-14 to 2016-17.
