

The above approval is subject to the following conditions:

1. The facility created by the unit shall be for its exclusively use.
2. The Unit/Service Provider shall not be eligible for any exemption, drawbacks, concession, direct/indirect tax or any other benefits available under Section 7 or Section 26 of SEZ Act for crating or operating such facilities.
3. The unit shall adhere all the statutory compliances such fire-NOC, PHO NOC.
