**Agenda Item No.01:-Confirmation of minutes of meeting held on 30.03.2022.**

The Approval Committee confirmed the minutes of meeting held on 30.03.2022 with consensus.

**Agenda Item No. 02:- Application for conversion of existing DTA into EOU of M/s. Sun Plast.**

The Committee noted the proposal for conversion of existing DTA into EOU at Plot No. 28B, 29, 30, 31, 34 & 36, Government Industrial Estate, Masat, Silvassa, Dadra Nagar Haveli-396230 for manufacture and export of "(i)

Polyethene Bags, (ii) Plastic Cup, (iii) Plastic Film, (iv) Aluminium Foil" with export turnover of Rs. 10,250/- Lakhs, NFE of Rs. 6,240.73 Lakhs, Investment in Plant & Machinery of Rs. 718.34 Lakhs And Employment of 251 Persons.

During the discussion, the Committee observed that export turnover for the year 2021-22 is more than Rs. 50/- Crore. Hence, the said proposal needs to be submitted to Board of Agenda. The applicant had mentioned that there is a typing error in proposed projection.

**Decision:-** After deliberation, the Committee deferred the proposal and directed the applicant to resubmit the revised application so that the proposal can be forwarded to Board of Approval.

**Agenda Item No. 03:-** Application for Setting up of New Unit of M/s. Indospun LLP

The Committee noted the proposal for setting up of New Unit at Survey No. 73/1 and 75/3, Ground floor, Karajgam Road near Kala, Karajgam, Dadra Nagar Haveli-396230 for manufacture and export of "Polyproplene Multifilament Yarn (PPMF)" with export turnover of Rs. 7,990/- Lakhs, NFE of Rs. 6956.44 Lakhs, Investment in Plant & Machinery of Rs. 2358.35 Lakhs And Employment of 120 Persons.

**Decision:-** After deliberation, the Committee approved the proposal for setting up of New Unit at Survey No. 73/1 and 75/3, Ground floor, Karajgam Road near Kala, Karajgam, Dadra Nagar Haveli-396230 for manufacture and export of "Polyproplene Multifilament Yarn (PPMF)" in terms of Para 6.05(a) of FTP 2015-2020 read with Para 6.01(b) of HBP 2015-20.
