**Agenda Item No. 2: Proposal of M/s. A.I. Commerce India LLP for setting up of a new unit at Arshiya-FTWZ, Raigad**

M/s. A.I. Commerce India LLP has requested for setting up of a new unit in Arshiya-FTWZ for Trading & Warehousing of All Items mentioned under ITC(HS) classification of Import and Export except prohibited, Canalized goods under Chapter 71 and transport services, Consolidation of Cargo, Packing, Re-packing, Labeling & Re-Labeling, Quality checking and Testing at Arshiya-FTWZ warehouse no. 08 and Proposed FOB value of exports of Rs. 734.86 Lakhs, FE Outgo of Rs. 520.78 Lakhs and NFE of Rs. 214.08 Lakhs & Employment of 9 persons.
