Confirmation of the Minutes of the 140th Meeting held on 06.11.2019.

The Minutes of the meeting held on 06.11.2019 were confirmed with consensus.

Agenda Item No. 02 :- Proposal for Setting up of unit in SEEPZ - M/s. S. G. Designs Pvt. Ltd.

M/s. S. G. Designs Pvt. Ltd. have submitted the application for setting up of a unit in SEEPZ for manufacture and export of Plain & Studded Bronze Jewellery, Plain & Studded Ceramic Jewellery, Plain Silver Jewellery, Precious and Semi-precious Stone Studded Silver Jewellery, Other Stone Studded Silver Jewellery, Plain Gold Jewellery, Pearl Studded Gold Jewellery, Diamond Studded Gold Jewellery, Precious and Semi Precious Stone Studded Gold Jewellery, Other Stone Studded Gold Jewellery, Plain & Studded Brass Jewellery, Plain and Studded Stainless Steel Jewellery, Plain and Studded Enamel Jewellery, Plain and Studded Titanium Jewellery at Plot No. 58, SEEPZ-SEZ.

The premises was in possession of M/s. Diastar Jewellery Pvt. Ltd., However, the premises was taken under SARFAESI Act by Bank of India. The E-auction was carried out and the premises was sold on behalf of Bank of India in favour of M/s. S. G. Designs Pvt. Ltd. M/s. S. G. Designs Pvt. Ltd., have made 25% of the bid amount and balance 75% of the sale proceeds is yet to be paid.

Diastar Jewellery Pvt. Ltd., and also on payment of balance sale proceeds by M/s. S.G. Design to the Bank of India.

Agenda Item No. 03 :- Proposal for Setting up of unit in SEEPZ by M/s. Indojewel Jewellery Pvt. Ltd.

M/s. Indojewel Jewellery Pvt. Ltd., has submitted the application for setting up of unit in SEEPZ for Service Activity viz. Grading, Assortment, Certification and Viewing of Rough & Polished Diamonds at Unit No. 001, Multistoried Building, SEEPZ-SEZ, Andheri East, Mumbai - 400096. M/s. Indojewel Jewellery Pvt. Ltd., were allotted unit No. 001, Multistoried Building on 21.03.2007 by MIDC and Possession was granted on 20.04.2011. Eviction Order issued to the unit for non-payment of rental dues and Non-execution of sub-lease agreement on 17.05.2018. The unit filed an appeal vide Misc. Appeal No. 8426 of 2018 at Bombay City Civil Court at Bombay and challenged the Eviction Order. The Court on 12.07.2018 was pleased to grant interim relief in terms of stay of operation till the next date of hearing i.e. 11.02.2020.

During discussion, Unit representatives informed that they procure rough diamond (with Kimberly certification) and process the same to semi-polished stage. Now they wish to import the semi-polished pieces into India. These will not carry Kimberley Certificates as same are not applicable to semi-polished diamonds. They also informed that usually rough diamonds are imported and this may possibly be the first such unit in SEEPZ. The Committee tried to understand the methodology of maintaining one to one co-relation.
