**Trade Facilitation Circular No. 01/2020-21**


**Subject : Repairs and day-to-day maintenance of SDFs, Gems & Jewellery Complexes and Common areas in SEEPZ SEZ.**

Attention of all Unit holders and other stakeholders at SEEPZ, is invited to the above subject. The need is felt to reach out to the unitholders of each building to ascertain the specific requirement of the building about nature of repairs like immediate, minor repairs and major repairs and to put in place a transparent system for the same with participation of the trade.

Accordingly, whatsapp groups were formed building-wise and meetings were conducted under the Chairmanship of Chairperson (Development Commissioner), Secretary (Joint Development Commissioner) and Estate officials with the Trade representatives on Webex application. The Trade was explained that all the immediate/urgent/minor repairs will be attended to on priority for which a Committee needs to be constituted comprising of 2 Owners 2 members from the management level building wise alongwith 2 officials of the Authority. Accordingly, the Committee were formed building-wise based on the names suggested by trade.

The Committees thus constituted are mentioned at Annexure 'A' to this circular who would list out the immediate/urgent repair work and convey to Authority for approval. On approval of the Authority, the said materials would be purchased based on the availability and the quantum through GeM portal. The goods which are not available on Gem will be purchased through Contractor after recommendation of the respective Committee and approval of the Competent Authority. The Contractor would post pre-and post pictures on the linked module on the website of the work thus executed. On satisfactory report of the Committee the bills of the contractor would be released.

The Committees thus constituted are requested to identify/inspect/monitor the work and help the SEEPZ SEZ Authority for fast and speedy execution of the work and avoid any complaints from the Trade.
