

Agenda Item No. 2: Proposal of M/s. Dow Chemical International Private Limited for setting up of a new unit at Arshiya-FTWZ, Raigad.

After deliberation, the Committee approved the proposal of M/s. Dow Chemical International Private Limited for setting up of FTWZ unit at Arshiya-FTWZ, Raigad envisaging FOB value of exports of Rs. 1172920.00 Lakhs, FE outgo of Rs. 1055628.00 Lakhs and NFE of Rs. 117292.00 Lakhs over a period of 5 years with employment generation to 5 (3 Men 2 Women) for Trading and Warehousing Activities: Consolidation of Cargo, Packing, Repacking, Labeling,. The Committee directed that the Specified Officer may verify the items proposed for Trading & warehousing activity and submit the final list of items as there are many items repeated with different ITC HS code classification. The LOA may be issued to the applicant unit indicating the items verified by Specified Officer, Arshiya-FTWZ.

Further, the Committee also directed that:

- i. All transaction shall be made in free foreign exchange in terms of SEZ Rules, 2006.
- ii. The applicant company shall obtain all requisite licenses from concerned authority whenever required.
- iii. The unit shall not import/export Prohibited/Restricted items.

Agenda Item No. 3: Proposal of M/s. Om Commodities Pvt. Ltd for Extension of LOA.

The representative of the unit did not attend the meeting, The Developer stated that the unit may not implement the project. The committee directed the Developer to submit the letter to Office of Development Commissioner, SEEPZ-SEZ for action on LOA of the unit in this case.
