**(I) Procedure for submission of tender is as follows:**

1. The tender shall be awarded for a period from **5<sup>th</sup> April, 2017 to 4<sup>th</sup> July, 2017.**

2. The envelope containing quotation shall be super scribed as **SEEPZ SEZ Tender for disposal of non-hazardous solid waste**. The envelope shall clearly indicate the name of the Agency.
3. The envelope shall contain the following:
  - a. Financial quotation shall indicate rate per KG offered for each item separately as indicated above. However, the award will be on the basis of total value calculated on the basis of weighted average garbage of last 3 months.
  - b. Demand Draft of Rs. 50,000/- (Rs. Fifty Thousand only) in favour of SEEPZ SEZ Authority Fund towards Earnest Money Deposit.
  - c. Self certified copies of PAN & TIN.
4. The Tender shall be deposited in the Tender box at ground floor, Service Centre Building.
5. If Tenderer not complying with conditions then tender can be rejected by Tender committee.

**(II) Opening of Quotations :**


**The last date for submission of quotation is 27.03.2017 till 12.00 am.** The sealed quotations shall be opened by the Tender Committee on the same date at **3.00 p.m.** in the conference hall of the Office of the Development Commissioner in presence of bidders and or their representative.

**(III) Terms of Contract:**

1. The awarded shall deposit Rs. 2,00,000 ( Rs. Two Lacs only) within 3 days of awarding of contract.
2. Once the deposited amount of Rs. 2,00,000/- (Rs. Two Lacs only) is exhausted, advance shall be deposited by the awarded for subsequent lifting of garbage.
3. VAT and TCS shall be charged extra.

4. The garbage shall be lifted to ensure that the kachra kundi remains clean. No garbage shall be accumulated near the dump area.
5. The garbage shall be lifted on every alternate day.
6. In case the contractor fails to lift the garbage on every alternate day he shall be liable for a fine of Rs. 5000 (Rs. Five Thousand only) and if the garbage is not lifted for more than a week the contract shall be terminated and the contractor will be blacklisted. The Tender will be given to the next bidder without calling any fresh quotations.
7. The bill shall be prepared by the Authority billing section after determination of weight of Non- Hazardous Solid waste, as per the rate at which, the Quotation has been accepted. Applicable taxes on the bill will also be payable by the successful Contractor.
