**Agenda Item No.1: Confirmation of Minutes of the 6<sup>th</sup> meeting held on 22.02.2018.**

Minutes of the 6<sup>th</sup> Meeting held on 22.02.2018 were confirmed.

The Committee discussed the progress of the activity in the JNPT SEZ. The representative of JNPT SEZ has stated that the work is in full swing and they will complete the basic infrastructure within the year end.

The Committee directed to submit the following:-

- 1) Action plan of SEZ operations.
- 2) Timeline of completion of infrastructure to ensure LOA of the unit is operational within stipulated time limit.
- 3) Likely scheduled of operation of SEZ.
- 4) Time scheduled for handing over basic facility i.e. usater, electricity, maintenance etc to unit holders.

**Agenda Item No.2: Application for setting up of a new unit - M/s. Krish Food**

**Industry (India) - M/s. JNPT SEZ.**

After deliberation, the Committee **approved** the proposal of M/s. Krish Food Industry (India), for setting up of a New Unit for Confectionery Items, Bubblegum, Corrugated Boxes at JNPT SEZ, Nhava Sheva, JNPT Port, Taluka Uran, Navi Mumbai Maharashtra, admeasuring area 8,000 Sq. mtr., envisaging FOB value of Rs. 20392.00 Lakhs, NFE of Rs. 13431.10 Lakhs and employment generation of 95 employees over the period of 5 years. Subject to compliance of stock limit of sugar as stipulated by Government from time to time.

**Agenda Item No.3: Application for setting up of a new unit - M/s. Oil Field Warehouse & Services Ltd. - M/s. JNPT SEZ.**
