

Sub: Invitation of application for Nomination as member of SEEPZ-SEZ Authority.

Sir,

SEEPZ-SEZ Authority is the governing body for development and maintenance of infrastructure in the SEEPZ Special Economic Zone. The Authority comprises of four ex-officio permanent members (including Chairperson) and 2 nominated members from Trade. The tenure of existing nominated members likely to be over by two months. Therefore, the Authority is being reconstituted with fresh nomination of two members from the units in SEEPZ-SEZ.

In case you are willing to be considered for nomination, please send your willingness before 16th February, 2017. It may kindly be noted that the nominated members would be required to attend meetings of the Authority as and when called. Normally meetings are held on quarterly basis. Before convening a meeting, a notice of 15 days is given.

Only Managing Director/Director (on Board of the company)/Managing Partner and Proprietor of the units would be eligible to be nominated. Delegation of the nomination is not permitted. The nominated member shall be deemed to have vacated the membership on occurrence of one or more of the following:-

- (i) Resignation from the Special Economic Zone Authority
- (ii) Death of the member
- (iii) The unit represented by the member defaults in payment of dues to the Special Economic Zone Authority concerned
- (iv) The member absents himself/herself in attending the proceedings of the Authority of three consecutive meetings

- (v) If any criminal proceeding is initiated against the unit represented by such member either by the State or Central Government for violation of any law for time being in force
 - (vi) The unit represented by such member is sick, closed or has not been exporting for more than six consecutive months and
 - (vii) Letter of Approval issued to the unit represented by the entrepreneur is cancelled by the competent Authority for reasons of fraud, misrepresentation etc.
