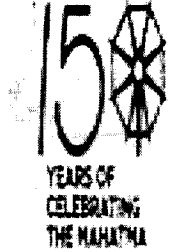

This is with reference to the Epidemic Diseases Act, 1897, Disaster Management Act, 2005 & various Notifications/ orders issued under the powers conferred there under & the Notification No. DMU/2020/CR.92/DisM-1 dt. 02.05.2020 wherein the GoM has extended lockdown upto 18.05.2020. The said notification provides certain relaxations in the lockdown situation.

Attention is invited to the para 7 (ii) (h) of the GoM guidelines dt. 02.05.2020, which specifies that all pre-monsoon related works including the protection of building, shuttering, water proofing, re-strengthening, water proofing etc. is acute necessary and needs to be carried out. As the said guidelines provides relaxation for such type of work with prior permission of Municipal Corpn. and as some unit holders willing to proceed for repairing work of the building/premises during the lockdown period, all the Unitholders are hereby permitted to execute the work subject to following conditions :-

- A necessary permission by Competent Authority, MC/MCGM, should be produced as per the instructions issued by GoM
- SOP as specified by Govt. needs to be followed strictly
- Unitholder itself will be solely responsible for any breach of condition and liable to face penal action under appropriate act.

All the unit holders within SEEPZ-SEZ are therefore hereby directed to follow the said instructions for pre-monsoon repairing work and directed to apply for permission for requisite permission to proceed the work.
