Agenda Item No.03: Monitoring of the performance of M/s. Nectar Infotel Solutions Pvt. Ltd.


After deliberation, Committee monitored the performance of the Unit for the block period 2015-16 to 2018-19 in terms of Rule 54 of SEZ Rules, 2006 and observed that an amount of Rs. 308.04 lakhs is pending remittance beyond the permissible period. The Committee also noted that the unit has already been granted extension upto 31.07.2020 by the A.D. Bank, and extension beyond the date is pending receipt.

Bank / RBI, as the case may be and submit the same to this office, upon which the performance will be monitored by the Approval Committee.
