**Agenda Item No. 02: Application for Additional List of Services of M/s. Jawaharlal Nehru Post Trust - SEZ.**

After deliberation, the Committee approved the following services required for authorized operations by the unit:

**Agenda Item No. 03: Application for setting up of New Unit M/s. SG Pharma Pvt. Ltd. in M/s. Jawaharlal Nehru Port Trust - SEZ.**

After deliberation, the Committee approved the proposal of M/s. SG Pharma Pvt. Ltd. for setting up of a new unit for Manufacturing process only at Plot No F3, at JNPT-SEZ, developed by JNPT, Uran, Navi Mumbai - 400 702, subject to submission of revised List of Goods & Projections for period of 5 years.

Also, the Developer requested for Trading and Export of Goods manufacturer in DTA on Sub-Contracting. The Committee directed the unit to submit application for trading in separate LOA. The Committee did not approve Export of Goods Solely manufactured in DTA on Sub-Contracting basis as the same is not permissible under SEZ Rule.

**Agenda Item No. 04: Application for setting up of New Unit M/s. OWS Warehouse Services LLP in M/s. Jawaharlal Nehru Port Trust - SEZ.**

After deliberation, the Committee approved the proposal of M/s. OWS Warehouse Services LLP for setting up of a new unit at Plot No E8, at JNPT-SEZ, developed by JNPT, Uran, Navi Mumbai - 400 702 envisaging FOB value of exports of Rs. 1050 Lakhs, FE outgo of Rs. 83 Lakhs and NFE of Rs. 966 Lakhs over a period of 5 years with employment generation of 16 (12 Men & 04 Women) for Limited Liability Partnership.
