Subject: Execution of Bond cum Legal Undertaking (BLUT)-reg

With the implementation of 100% e-Office and to enable smooth functioning and to adhere to the time line prescribed under Rule 22(iv)(g) of SEZ Rules, 2006, following procedure will be adopted for submission of process/ acceptance of BLUT henceforth and with immediate effect :


- All the stakeholders needs to submit the complete BLUT in Triplicate (One Original + 2 Colour Xerox) along with supporting documents to DC Office SEEPZ SEZ directly.
- The BLUT will be verified with reference to Rule 22(iv) of SEZ Rules, 2006 and approved projections in DC Office by respective ADC's
- The BLUT will be diarized in e-Office and if found proper, on verification by the concerned ADC, will be forwarded to the jurisdictional Specified Officer for duty verification and approval in e-Office.
- The jurisdictional Specified Officer will forward the same to the Jt. Development Commissioner, for necessary approval or he/she will return the same to ADC, if duty calculation is not proper.
- Post approval by the Jt. Development Commissioner in e-Office, signature of the Specified Officer and the Jt. Development Commissioner shall be obtained on the hard copy of the BLUT, by DC Office.
- Thereafter certified copy of the BLUT shall be forwarded to the concerned unit/developer and Specified Officer for record purpose latest within one working day.

The above procedure will be applicable to all the SEZs located in Mumbai SEZs. Any difficulty in this regard, may be brought to the notice of the undersigned.
