Agenda Item No. 01:-

Confirmation of the Minutes of the 139th Meeting held on 16.09.2019.

The Minutes of the meeting held on 16.09.2019 were confirmed with consensus.

Agenda Item No. 02 :- Application received for Setting up of unit in SEEPZ - M/s. Transasia Bio-Medical Ltd.

The unit has submitted the application for setting up unit in SEEPZ for manufacture and export of Electronics, Medical, Equipments & Analyzers at Unit No. 177B, SDF VI, SEEPZ-SEZ. M/s. Transasia Bio-Medical Ltd., were provisionally allotted unit No. 177B on 09.02.2017 subject to condition that the Final allotment and possession will be granted on approval of project by UAC. Since, no possession was granted they had filed the Writ Petition (1) No. 3475 of 2017 before Hon'ble High Court.

M/s. Transasia Bio-Medical Ltd., have conveyed that they will withdraw the case & obtain judgment from Court.

Agenda Item No. 03 :- Application received for Setting up of unit in SEEPZ for doing E-Commerce Facility - M/s. Minal Infojewels Ltd.

The unit has submitted the application for setting up of unit in SEEPZ for e-commerce activity by using multiple platforms like Amazon, Ebay Ali Express, Tophatter, Open Sky and Own Portal. The unit's proposal was placed in the UAC meeting on 30.05.2017, wherein the Committee had referred the proposal to MOC&I as the SEEPZ-SEZ is two sector (Electronics & Gems & Jewellery). This office had informed the same to MOC&I.

The unit had once again requested to allow them to do the trading and warehousing facility under Rule 76 of SEZ Rules 2006 under Broad Banding Facility. This office further informed MOC&I that the SEZ is for manufacturing in two sector (Electronics+Jewellery), therefore the manufacturing of other items cannot be considered. However, to facilitate the e-commerce business of SEZ unit, trading/warehousing of other sector (other than existing Gems & Jewellery and Electronic Hardware Sectors), such as lifestyle product, leather products, and stationary, electronic product etc. (Garment, purses, pen etc.) may be considered subject to the conditions that all e-commerce shipment will have a jewellery product apart from other items. All exports are subject the conditions as stipulated in Export-Import policy. This facility will be limited to e-commerce shipments only.
