### CIRCULAR NO./LAB/68/2022-23

In accordance with the powers delegated to the Development Commissioner of SEZ by the Govt. of Maharashtra, under the Minimum Wages Act, 1948 the jurisdiction in respect of units in SEZs for implementation as well as for taking necessary action for violation, if any, are with this office. Further this power has been delegated to Deputy Development Commissioner by Development Commissioner vide Office Order No. 293/309 dated 10/08/2022. As on date, the minimum wages applicable to the un-skilled, semi-skilled and skilled workers/employees in the SEEPZ (Electronics) and Gems and Jewellery Sectors are mentioned below:- (Special Allowance revised for the period of 01/07/2022 to 31/12/2022)

The Zone Administration will be regularly verifying the records and registers to ensure payment of minimum wages by employers, by obtaining photo copies of payment register for specified period.
