The Committee noted that the unit was granted LOA No. PER:92(2004)/SEEPZ-SEZ/EOU/IA-II/25/04-05/5568 dt. 28.07.2004 as amended for manufacture and export of Washers, Clips, Hose Clip, Ring, Dipstick, Clamps, Cage Nut. The validity of the LOA was up to 31.03.2020.

The unit has applied for renewal of LOA vide letter dt. 26.08.2020. It is noticed that, the unit has not made any export/import during the period 2017-18, 2018-19 and 2019-20.
