Circular No. 02/ 2021

Sub: Removal of debris by Unit holders and public utilities reg....

It is witnessed after due physical inspection that the spirit of "Swaachh Bharat Abhiyaan" is grossly undermined with waste/debris/scrap material lying around buildings in an unauthorized manner and in defiance of earlier circular no. 13/2020 dt. 09.10.2020.

After multiple inspections, it is noticed that there are lot of debris/unauthorized materials stacked in and around the common passage and the unit premises which are to be removed at the time of renovation of the Unit.

All Unit holders are supposed to remove the derbies/unauthorised material from the unit premises as well a common passage as per the condition in permission letter for carrying out renovation, repair, civil and other permission within time frame of the days as mentioned in the letter. It is observed that the same it is not followed by Unitholders properly and it leads to hindrance to other units. This is also blocking and seriously hampering emergency exit passages and approach for emergency services like fire tender etc.

Hence, it is resolved that if such unauthorized materials/debris stacked or found in and around the unit premises common passage, same shall be removed and shifted immediately by the units to the scrap/ waste segregation points as indicated at Annexure 'A' to this circular within 14 (fourteen) working days of the issue of this circular and with immediate effect.

The Committees constituted for the various buildings in SEEPZ SEZ processing zone are to supervise the clearance of the scrap/debris/waste material from the premises. After the period of 14 (fourteen) days, physical site inspection and photographs (with the date & time stamp) shall be taken and in case of any waste/scrap/debris etc. found lying unattended to shall be liable for penal action under relevant provisions of the SEZ Act and Rules thereof with pecuniary penal fine of @ Rs. 1000/- (one thousand) per defaulting unit per day for the next 10 (ten) working days and failure to comply with the said instructions shall thereafter result in prosecution with registration of cases with Competent Authority.

The Specified Officer, SEEPZ shall assess any duty that shall be applicable for any such goods under the SEZ Act & Rules thereof on referral from the unit for expeditious removal. Units having to face any issues per such clearance should apply to the SO, SEEPZ and the SEEPZ Authority accordingly.

All Unitholders/public are hereby directed to abide to the terms and conditions of the said circular.

This issues with the approval of the Competent Authority, SEEPZ-SEZ.
