Agenda Item No. 2: - Approval of addition of space with revised Projection of M/s. Infosys Ltd (Unit - I).

After deliberation, the Committee approved proposal of M/s. Infosys Ltd (Unit - I) for addition of area of 1.33 Lakhs Sq ft. at 3rd to 4th Floor, Cypress building, Ascendas IT Park (Co-Developer), MIDC SEZ, Hinjewadi, Pune with revision of projections. Original projections for the remaining period of three years were Export Rs. 392230.00/- Lakhs, FE outgo Rs. 228700.00/- Lakhs, NFE Rs. 163530.00/- Lakhs and Employment 4800 against which the revised projections will be Export Rs. 464780.00/- Lakhs, FE outgo Rs. 273190.00/- Lakhs, NFE Rs. 191590.00/- Lakhs and Employment 6000.
