### Agenda Item No.01: Confirmation of Minutes of the 84<sup>th</sup> meeting held on 05.08.2020

The Committee examined the minutes of the 84<sup>th</sup> Meeting held on 05.08.2020 and after deliberation confirmed the minutes of the meeting.

### Agenda Item No.02: Application of M/s. All Scripts (India) LLP, an IT/ITES Unit located in EON Kharadi Phase-I SEZ for sharing common network infrastructure facilities with their another SEZ unit located in EON Kharadi Phase-II.

After deliberation, Committee examine the proposal of the unit in terms of Rule 27(5) of the SEZ Rule and clarification of MOC&I dated 06.02.2019 addressed to Development Commissioner NOIDA in case of request of M/s RBS Services India Pvt. Ltd. and approved the proposal of M/s. All Scripts (India) LLP, for sharing common network infrastructure facilities with their another SEZ unit M/s. Allscripts (India) LLP located in EON Kharadi Phase-II-SEZ, as detailed below ;

**Common Network Infrastructure Facility to be shared:**

<b>Sr. No.</b>	<b>Particulars</b>	<b>Purpose</b>
1	Network LAN	Both units will be sharing one network LAN for purpose of seamless connectivity.
2	Firewall	Both units will be sharing common firewall for the purpose of monitoring traffic, usage, security and seamless connectivity.
3	VPN Gateway	For the purpose of security of data by means of encrypting data traffic.
4	Network Internet Link	For purpose of accessing internet for browsing, email etc. by unit employees.
5	Network WAN Link	For facilitating communication, the sharing of information etc. by between the two units.
6	Network Print Server	For the purpose of single point connectivity. It connects printers to computers of the two units over a network.
7	Server Infra DNS, Software Deployment	For the purpose of mapping domain names to connected resources, designating authoritative name servers for each domain.
8	Routers	Both units will be sharing common routers for the purpose of connecting multiple networks.

**Agenda Item No.03: Monitoring of performance of M/s. Symantec Software India Pvt. Ltd.**

After deliberation, Committee noted the performance of M/s. Symantec Software India Pvt. Ltd. in terms of Rule 54 of SEZ Rules,2006 and also noted that the unit has achieved positive NFE of Rs 102985.42 Lakhs on cumulative basis with an employment of 1905 employees during the period of two years i.e. 2017-18 and 2018-19.

**Agenda Item No.03: Monitoring of performance of M/s. Vodafone India Services Pvt. Ltd.**

After deliberation, Committee noted the performance of M/s. Vodafone India Services Pvt. Ltd. in terms of Rule 54 of SEZ Rules,2006 and also noted that the unit has achieved positive NFE of Rs 254309.47 Lakhs on cumulative basis with an employment of 4316 employees during the period of four years i.e. 2015-16 and 2018-19.

Further, the Committee was appraised that while filing Softex for the period from 2015-16 to 2018-19, unit failed to comply with Rule 19(7) of SEZ Rule and filed common Softex for their SEZ units and Domestic Tariff Area units to the Development Commissioner's office for certification, where as they are supposed to maintain separate accounts. This has also resulted into wrong data.

However, after end of the financial year as per their audit report, they are rectifying the same by way of issuance of credit note and are filing correct figures in their APR filed for the respective Year as well as in Form 56F filed with the Income Tax Authorities.

The Committee, after deliberation, concluded that, as the unit is well aware that they are required to file Softex for certification to Development Commissioners office only for the exports effected from their unit located in SEZ, for which LOA has been issued, yet, they continued to file Softex by including export made from their Non-SEZ unit, and as such have filed Softex giving false information with the Department as well as other regulatory agencies viz. RBI etc.

Accordingly, the Committee felt that action be initiated against the unit for violation of various provisions of SEZ Act/Rule under the provisions of Foreign Trade (Development & Regulation ) Act, 1992 by the Development Commissioner, as deemed fit.
