Table Agenda Item No.01: Application submitted by M/s. Tech Mahindra Ltd. (Unit-II) for permission for setting up project by way of Co-locating.

The Unit representative Ms. Dhanshree Bhat explained that they are in the process of finalizing a deal with their overseas client who are Global Telecom Company, and wish to set up a project in the premises of their Unit-II location. wherein they propose to engage the services of around 1000 Full Time Employees(FTE) within the next 6 to 12 months and that the said FTEs would be comprising of employees of both i.e of M/s. Tech Mahindra Ltd. as well as their Client. Ms. Bhat also explained that services of other personnel's, who may be other than Tech Mahindra and their client' s may also be required for a short duration or for limited time period.

Ms. Bhat further explained that that M/s. Tech Mahindra Ltd. will be charging their client i.e. raising the bill and the remittance will be credited in the account of M/s Tech Mahindra Ltd. She further said that salary of the employees of Tech Mahindra Ltd. will be paid by them whereas other employees will be on the payroll of their client.

After hearing the unit's representative and discussion, Committee came to conclusion that there are no provision in the SEZ Act or Rules for granting permission for co-location of employees of a non-SEZ unit in the unit premises of a SEZ Unit. Therefore, Committee decided that the request of M/s. Tech Mahindra Ltd. for setting up a project by way of Co-locating of the employees of the client into their SEZ premises, cannot be acceded to.

Meeting ended with a vote of thanks to the Chair.
