PUBLIC NOTICE NO. 33/2021

Subject:- Goods recovered by SEEPZ-Security at SEEPZ Gates-reg.

It is brought to the notice of all concerned including SEEPZ-SEZ units, visitors and employees of units etc. that there have been several instances in SEEPZ-SEZ wherein some persons have been found carrying precious items & other dutiable goods without any proper documents/permission by Authorised Officer. These precious items/dutiable goods may or may not be for authorised operations of any unit.

Usually, these precious items/dutiable goods belong to the unit. However, in some cases, it is found that these items are the personal property of the Unit's employees/visitors who have been apprehended by the security.

It is incumbent on the units in SEEPZ-SEZ to sensitize their visitors/employees that SEEPZ-SEZ is a restricted area wherein such precious/dutiable items are not to be brought inside or allowed to be taken out without proper permission / documentation. However, it is observed that the units are not exercising due diligence in sensitizing their employee/visitors about the restrictions which has led to an increase in violation of the SEEPZ-SEZ Rules.

In view of the above, it is hereby informed that henceforth, if any visitor/employee of the unit is found with such items without proper documents then he/she will be fined Rs. 5,000/- which may extend up to the value of the goods, as decided by the Development Commissioner, SEEPZ-SEZ depending upon the facts of the case and the investigation conducted by the Specified Officer. The unit will also be penalized accordingly for violation of security of SEEPZ. The said amount shall be collected through ADC/Estate to be deposited in SEEPZ-Authority Account.

In other cases i.e. wherein the goods/items are found to be the property of the unit, action will be taken under FTDR Act, 1992/Customs Act, 1962 or any other law for the time being in force at the time of such violation.

This issues with the approval of Development Commissioner, SEEPZ-SEZ.
