M/s. Nhava Sheva Business Park Pvt. Ltd., submitted an application for new unit in FTWZ at JNPT-SEZ for Other Business services such as Inventory Management services, Order Processing, Services Auxiliary to all modes of Transport such as Logistics and Related services, Cargo Handling Services, Human Resource Services such as Supply of manpower, Transport Services such as Freight and related services, Warehousing Services (Including Storage services) admeasuring area 1007.50 Sq. mtr envisaging FOB value of exports of Rs. 706.25 Lakhs, FE outgo of Rs. 125.45 Lakhs and NFE of Rs. 580.80 Lakhs over a period of 5 years with employment generation of 16 nos. (12 Men & 04 Women). The proposal was taken up in Approval Committee meeting held on dated 11.01.2021 and certain queries were raised by the Committee which the representative has replied.


