
Agenda Item No. 01: Confirmation of Minutes of the meeting held on 21.04.2017.

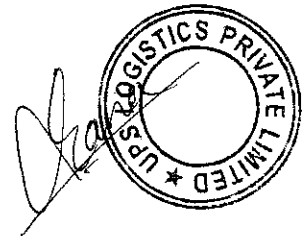
