**Agenda Item No. 02: Application extension of time for submission of registered lease Deed of M/s. Oil Field Warehouse & Services Ltd.**

The representative of the unit stated that they have made 1<sup>st</sup> installment payment in last year after which agreement to lease deed was to be executed by JNPT authority which is still pending. As the Developer has said that the plots will only be in a position to be handed over to the Unit by December, 2019.

After deliberation, the Committee extended the period for six months (i.e. upto 31.12.2019) and directed the unit to submit the registered lease deed within that period.

After deliberation, the Committee approved the proposal of M/s. RK Flexo Printers Packers LLP for setting up of a new unit for Manufacturing process at Plot No E10, Admeasuring 4,600 Sq. Mtr, JNPT-SEZ, developed by JNPT, Uran, Navi Mumbai – 400 702 envisaging FOB value of exports of Rs. 4760.25 Lakhs, FE outgo of Rs. 580.31 Lakhs and NFE of Rs. 4179.94 Lakhs over a period of 5 years with employment generation of 28 nos. (20 Men & 08 Women).

After deliberation, the Committee approved the proposal of M/s. Rudra Flexipack LLP for setting up of a new unit for Manufacturing process at Plot No E9, Admeasuring 4,000 Sq. Mtr, JNPT-SEZ, developed by JNPT, Uran, Navi Mumbai – 400 702 envisaging FOB value of exports of Rs. 5210 Lakhs, FE outgo of Rs. 664.62 Lakhs and NFE of Rs. 4545.38 Lakhs over a period of 5 years with employment generation of 28 nos. (20 Men & 08 Women).

**Agenda Item No. 05: Application for setting up of New Unit M/s. R.K. Sweet Mars Pvt. Ltd in M/s. Jawaharlal Nehru Port Trust – SEZ.**

After deliberation, the Committee approved the proposal of M/s. R.K. Sweet Mars Pvt. Ltd. for setting up of a new unit for Manufacturing and processing of Confectionery items, Biscuit items at Plot No E4, Admeasuring 7,000 Sq. Mtr, JNPT-SEZ, developed by JNPT, Uran, Navi Mumbai – 400 702 envisaging FOB value of exports of Rs. 15542.50 Lakhs, FE outgo of Rs. 4186.75 Lakhs and NFE of Rs. 11355.75 Lakhs over a period of 5 years with employment generation of 90 nos. (65 Men & 25 Women).
