


Sir,

OFFICE MEMORANDUM

Sub: Implementation of the Recommendation of Baba Kalyani Committee related to Skill Development-reg.

The undersigned is directed to refer to Ministry of Commerce & Industry's OM no. K.43013(13)/1/2020-SEZ dated 17.12.2020 on the above cited subject. In the Skill Plan of MSDE contained in the Appendix to the SGoS document, SEZ amongst other areas like logistics, WTO negotiations, etc. have been identified as major skills required under the domain of DoC. As far as skilling schemes of the Ministry are concerned, both the long-term training (ITI) eco-system and the short-term training (PMKVY) eco-system offer NSQF-aligned job roles/ trades which are being/ can be used for preparing skilled manpower for units in various sectors, including those operating in the functional SEZs. If there is need for any specific skill-set for which existing qualification packs (QPs) are not able to suffice, new QPs can be prepared through awarding bodies like relevant sector skill councils and approved by the skills regulator, NCVET/ NSQC.

2. Further, it is requested that, in the SEZ law, it may be mandated that the promoter setting up the SEZ should also be required to set up a Skill Training Centre for providing skilling support to industries located in the SEZ
