Agenda Item No.01: Confirmation of Minutes of the meeting held on 25.07.2017.

The Minutes of the 29th Meeting held on 26.07.2017 were confirmed.

Agenda Item No. 2: Application for Unit Regularization - M/s. Syntel Pvt. Ltd. - M/s. Syntel International Pvt. Ltd. - SEZ.

The approval Committee noted that M/s. Syntel Pvt. Ltd. was issued LOA No. SEEPZ/SIPL-SEZ/SL/2012-13 dated 03.02.2014 for export of IT/ITES. The initial validity of the LOA was upto 02.02.2016. The Unit had applied for 2nd

extension vide letter dated 01.02.2016. A deficiency letter dated 19.02.2016 and a reminder letter dated 24.05.2016 was issued to the Unit. However, no response was received and unit's extension could not be granted. In between, Unit applied for additional list of services vide letter dated 16.06.2016 and 1.12.2016 which were taken up in the UAC held on 15.07.2016 and 13.01.2017 respectively and UAC approved the additional list of services. Thereafter, the Unit applied for 3rd extension to the LOA vide letter dated 14.02.2017. In the meantime, the Unit informed the commencement of production w.e.f 05.06.2017.

After deliberation, the Committee noted that the Unit applied for extension of LOA in time and UAC in two meetings approved the list of services and hence regularised the extension of LOA from period w.e.f 03.02.2016 to 05.06.2017 till the DCP date.
