

The approval is subject to the following terms and conditions:

- (i) Only ready to eat food/pre-cooked food will be served,
- (ii) No inflammable will be used for cooking / heating,
- (iii) The Unit as well as the Service Provider will not be eligible for any exemptions, drawback, concessions or any other benefit available under Section 7 or Section 26 of the SEZ Act for creating or operating such facilities.
- (iv) The Unit/Service provider shall adhere all the statutory compliances, as required for setting up / running of such facility.

The Committee further directed the developer to ensure that the Fire NOC is renewed periodically every six months and to further ensure that in case of any change in the floor plan / layout plan of the premises or cafeteria, updated Fire NOC for such changes is obtained by the Unit.
