**Agenda Item No. 03:- Approval for Enhancement of Limit for Imported  
And Indigenous Capital Goods – M/s. Tieto India  
Pvt. Ltd. (Unit – 1).**


After deliberation the Committee approved the Enhancement of Limit for Imported Capital Goods of Rs. 400/- Lakhs And Indigenous Capital Goods of Rs. 1581.70/- Lakhs for their SEZ unit in the existing LOA as per Rule 19 (2) of SEZ Rules, 2006 with revision of Projection for a remaining period of 2 years viz. 2017-18 and 2018-19 with FOB Value of Export of Rs. 1,01,607.31/- Lakhs and FE Outgo of Rs. 16614.00/- Lakhs and NFE of Rs. 84,993.31 Lakhs. The unit shall submit the list of Imported/Indigenous Capital Goods before issue of Permission letter.

**Agenda Item No. 03:- Monitoring of Performance of the unit – M/s. SG  
Analytics Pvt. Ltd.**

After deliberation the Committee noted the monitoring of Performance of M/s. SG Analytics Pvt. Ltd. in terms of Rule 54 of SEZ Rules, 2006 for the Block period of 4 years for the year i.e. 2013-14 to 2016-17 with FOB Value of Export of Rs. 16,664.56/- Lakhs and the unit has achieved positive NFE of Rs. 12187.86 Lakhs.

The Committee also noted that the unit has Imported Capital Goods of Rs. 45.49/- Lakhs even though no Imported Capital Goods was permitted to the unit. The Committee directed that SCN may be issued to the unit for violation of terms and conditions of LOA.
