NOTIFICATION

INDUSTRIAL DISPUTES ACT, 1947.

No. IDA. 2001/4/CR-2386/Lab-3.—In exercise of the powers conferred by clause (b) of section 39 of the Industrial Disputes Act, 1947 (14 of 1947) (hereinafter referred to as "the said Act"), the Government of Maharashtra hereby directs that the powers exercisable by it under sections 3, 4, 10(1), 10(2), 10(3), 10(5), 10(A), 12(5), 17(1), 25-A(2), 25-FFA(2), 25-K(2), 25-M, 25-N, 25-O, 34(1) and 36-A of the said Act shall also be exercisable by the Development Commissioner, Special Economic Zone, in relation to industries situated in the Special Economic Zones in the State of Maharashtra.

2. And the powers conferred on the Commissioner of Labour, Mumbai under sections 4, 10(1), 10(2), 10(3), 10(5), 10-A, 12(5), 17(1), 25-A(2), 25-FFA(2), 25-K(2), 25-M, 25-N, 25-O, 34(1) and 36-A of the said Act, under
