

The application for setting up the project along with necessary supporting documents should be submitted in the prescribed Form – F, which can be downloaded from sezindia.nic.in.

The eligibility of the application will be decided as per the following criteria. However, preference shall be given to criteria which meet the objectives of SEZ, Act & Rules:-

- Export Projection
- Investment envisaged
- Employment envisaged
- Consolidation of Units at one place would be considered
- New/Innovative products / Unit would be considered
- The unit may give their preference for space, However, allotment will be made on the availability.
- Any other criteria as may be deemed fit by the Authority



- In order to promote small and medium enterprises, the Authority decided in its meeting held on 16<sup>th</sup> February, 2015 that the existing units who are possession of more than 35,000 sq. ft. of space in Government SDF's can be encouraged to opt for long term lease premises and preference shall be given to applicants who have possession of less than 35,000 sq. ft. of space in Government SDF's.
- Past credential of the unit giving projection will also be checked before accepting the projection.

The application in the Form F (without DD of Rs. 5,000/-) should be submitted furnishing requisite information. The applications received within the prescribed time limit will be scrutinized by a Committee. The eligible applicant will be allotted the space Final allotment will be made only after grant LOA by UAC.

If the applicant is existing SEEPZ units, the actual export achieved and employment during the year 2013-14 should be indicated. If the application is for expansion of activity under the existing LOA then, the actual export, NFE and employment during the year 2013-14 and the additional exports, NFE and employment envisaged for the next 5 years in respect of additional space to be furnished.

- The application in Form F should be submitted in sealed envelope addressed to Mrs. M. J.
