Supplementary Agenda Item No. 1:- Request of M/s. Nitin Fire Protection for Extension of Letter of Approval for setting up of a unit in Arshiya FTWZ.

The proposal of unit for setting up unit in Arshiya FTWZ was considered in Approval Committee meeting held on 02.05.2012. The committee approved the proposal for setting up a unit in FTWZ unit for Trading and Warehousing of High Pressure Cylinders, Fire Extinguishers, Fire Fighting Equipments, HFO pipes, Pressure Switch for Fire Extinguishers, Fire Alarm parts Detection Equipments and value added services viz. Packing, Unpacking, re-packing labeling, relabeling, MRP labeling, Tagging, Branding, Lashing, Unlashing, Choking, palletisation, shrink wrapping, display services, quality checking, testing and sampling and other related services, viz. weighment services, custom house agency services and cargo handling services, segregation, Fumigation of Cargo within FTWZ in terms of Rule 18(5) of SEZ Rules, 2006 and instructions issued by Ministry of Commerce and Industry from time to time.

The Committee rejected the request for permitting value added services for

1. Testing of Cylinders.
2. Filling of Gas (fire fighting chemicals) from the Tank container through filling machine into the empty extinguishers.
3. Weight measurement of filled Extinguishers through weigh machine.
4. Fixing of necessary fittings and caps to extinguishers and inspection of cylinders by self or by agencies before dispatch.

The unit was informed that they can file an appeal against the order of rejection of UAC before BOA as per provisions of SEZ Act & Rules.

The Letter Of Approval No. SEEPZ/NEWSEZ/ARSHIYA-RAIGAD/65/LOA-71/2011-12/7332 dated 18.05.2012 valid up to 17.05.2013 was issued to the unit.

For the rejected value added activities the unit had appealed to Board of Approval. In BOA meeting dated 06.07.2012, the board deferred the appeal, to examine, in detail the issue of permitting such activities in a FTWZ in light of provisions of SEZ Act/Rules.


The unit had requested for extension of the validity period of the Letter of Approval stating that they were unable to commence operations in FTWZ as their appeal for certain authorized activity was still under consideration of Board Of Approval. The unit was granted extension of LOA for further period of 3 months up to 17. 08.2013. But during the extension period unit did not commence the operation and LOA expired.

Now after 15 months the unit vide letter dated 23.12.2014 has applied for extension (for 4 months) after the expiry of LOA so as to complete the necessary formalities and then start operation.

Relevant Rule Provision:- Rule 19(4) of SEZ Rules, 2006.

Decision:- The Committee approved Extension of validity of the LOA of M/s. Nitin Fire Protection India. Ltd., till 30th April, 2015.
