CIRCULAR NO. 06

SUB: PERMISSION TO BRING TIFFINS THROUGH DABBAWALAS.

Representations have been received that the dabbawalas are not allowed to bring tiffins of employees of units, inside the zone. In this regard, it is clarified that the employees of the units are allowed to bring their tiffins inside the Zone directly or through dabbawalas, subject to security procedure of screening.

It is further clarified that dabbawalas are entitled to take Vendor gate pass for delivery of tiffins, to any of the units after following procedure as a Vendor, in accordance with procedure set out to Circular No.4. However, they will have to follow security procedure of screening.

It has been represented that screening of each tiffin takes time resulting in delay of delivery. In this regard, it is directed that tiffins brought by registered dabbawalas will not be subject to screening till 30th June, 2015. Thereafter, fast track screening will be introduced, whereby the tiffins will be put in trays and will be screened in bulk. In the meantime, dabbawalas are directed to obtain the Vendor pass immediately.
