### Circular No. 04

**Sub: Penalty for unauthorized dumping of debris/non segregation of waste/entry into SEEPZ-SEZ without gate pass or with invalid gate pass/entry of vehicle/without SEZ vehicle pass or with invalid vehicle pass/smoking in public.**

In supersession of all earlier Circulars on the subject cited above, this Circular will come into force with immediately effect. There have been repeated instances of storage of goods/ materials in the common area and dumping of debris in the common area, causing inconvenience to other units and adversely affecting the upkeep of the complex. Non- segregation of wet and dry waste has also been causing difficulty in providing wet waste to the bio gas plant. Other violations noticed are entry of person into the Zone without gate pass or with invalid gate pass, entry of vehicle into the Zone without vehicle pass or with invalid vehicle pass and smoking in public. All these issues were discussed in the meeting of the SEEPZ Authority held on 26.11.2014.

In order to prevent misuse of common area and to improve compliance in respect of the violation(s) /offence(s) mentioned above, the SEEPZ SEZ Authority in its meeting held on 26.11.2014 decided to impose penalty as follows:-

#### **1) Unauthorized dumping of debris**

Rs. 1,000/- Unauthorized dumping of debris and actual cost of removal of same.

Rs. 1,000/- per day for unauthorized use of common area.

**2) Non segregation of waste**

For non-segregation of wet and dry waste (atleast one Caution notice will be issued before imposing penalty).

Rs. 1,000/- for 1<sup>st</sup> offence.

Rs. 1,000/- to Rs.5,000/- for each subsequent offence.

**3) Security**

Rs. 1,000/- per person, for entry into the SEEPZ - SEZ without gate pass.

Rs. 200/- per person for entry with invalid gate pass.


Rs. 5,000/- for entry into the Zone without vehicle pass.

Rs. 1,250/- for entry with invalid vehicle pass.

**4) smoking in public**

Rs. 500/- for smoking in public.
