**CIRCULAR NO. 05 /2014**

The units were informed Vide Circular of even No. 01 dt 21.04.2015 to pay the outstanding gate pass charges by 30.04.2015. They were also informed that no gate pass will be issued w.e.f. 01.05.2015 if outstanding dues are not cleared. Subsequently, vide Circular No. 03 dt. 01.05.2015, gate passes were allowed to be issued on undertaking of units.

It has now been observed that some of the units still have not paid the outstanding gate pass charges.

The concerned units are once again directed to make payment latest by 30.06.2015. In case payment is not made by stipulated date, then one day free gate pass facility [i.e. Circular No 4 - Sr. No. 1(a), 1(b), 1(d)] will be withdrawn w.e.f. 01.07.2015. Thereafter, the defaulting units will have to take one day gate pass only on payment of Rs. 5/- for each gate pass and also on clearance of outstanding dues.
