The Minutes of the 15th Meeting held on 18.03.2016 were confirmed.



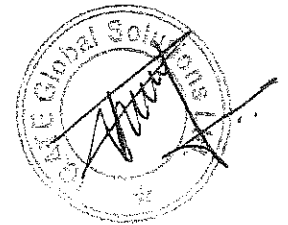
