The application for setting up the project along with necessary supporting documents should be submitted in the prescribed Form - F, which can be downloaded from sezindia.nic.in.

The eligibility of the application will be decided as per the following criteria. However, preference shall be given to criteria which meet the objectives of SEZ, Act & Rules:-

- Export Projection
- Investment envisaged
- Employment envisaged
- Consolidation of Units at one place would be considered.
- New/Innovative products / Unit would be considered
- Company in a group may be given preference, on basis of business plan, in case their other companies have surrendered units.
- The unit may give their preference for space, However, allotment will be made on the availability.
- Any other criteria as may be deemed fit by the Authority
- It is felt that units which have large scale operations and are well established may be encouraged to opt for long lease premises i.e. MIDC building or self-built factories constructed by allottees of land. This would enable the scarce space to become available for small and medium scale units who may not be able to afford investments in the premises. The units having allotment of 3000 Sq. Mtrs. Or more space may be encouraged to opt for Non Government premises.
- Past credential of the unit giving projection will also be checked before accepting the projection.

The application in the Form F (without DD of Rs. 5,000/-) should be submitted furnishing requisite information. The applications received within the prescribed time limit will be scrutinized by a Committee. The eligible applicant will be allotted the space Final allotment will be made only after grant LOA by UAC.

If the applicant is existing SEEPZ units, the actual export achieved and employment during the year 2014-15 should be indicated. If the application is for expansion of activity under the existing LOA then, the actual export, NFE and employment during the year 2014-15 and the additional exports, NFE and employment envisaged for the next 5 years in respect of additional space to be furnished.
