**I. Confirmation of Minutes of the 7<sup>th</sup> Meeting (2015 Series) held on 10.08.2015.**

The Unit Approval Committee ratified the minutes of its 7<sup>th</sup> meeting held on 10.08.2015.

**1. M/s. Dana India Technical Centre Pvt. Ltd.**

The Assistant Commissioner of Central Excise stated that they have submitted the report as discussed in the last Unit Approval Committee Meeting. M/s. Dana India Pvt. Ltd. an EOU had admitted the offence and paid the duty along with interest. The Incident report of DGCEI mentioned that the investigation are in progress. Further, as per FTP/HBP one of the criteria is that the unit should not have any case of violations against it (e.g. unauthorized diversion of goods etc.).

The Committee noted the view of the Central Excise Officer, however did not find any provisions in FTP/HBP which explicitly prohibits merger due to any violation on the part of the unit. In the present case there is an offence on the part of M/s. Dana India Pvt. Ltd. a different legal entity whereas M/s. Dana India Technical Centre Pvt. Ltd. an EOU has applied for merger of STPI unit into EOU.

The Committee directed that jurisdictional Central Excise may re-examine the case and inform the reason as to how the investigation/revenue part is affected on merger of STPI unit into EOU unit of M/s. Dana India Technical Centre Pvt. Ltd. within 15 days time. The case may be examined on file, approval may be granted to the unit and UAC may be informed accordingly.

**2. M/s. ION Exchange (India) Ltd.**

The representative of the unit did not attend the meeting. The Committee deferred the matter.

**3. M/s. Jell Pharmaceuticals Pvt. Ltd. (A division of Pan Aromas).**

The representative of the unit did not attend the meeting. The Committee deferred the matter.
