

Record of discussion in the Open House Meeting with MADDC Officers and Unit Holders under the chairmanship of Shri. NPS Monga, Development Commissioner, SEEPZ on 27th November, 2015 at MIHAN SEZ

Attendance: As per list attached.

The following points were discussed:

In his welcome speech, Shri. N.P.S. Monga, Development Commissioner informed that more than 500 SEZs were approved initially from the year 2005-2008. The reason for notifying SEZ was to foster sector specific activity of cluster to take place for ease of doing business. The main advantages of SEZ are that it offers a secure environment for business operations with minimum/no paperwork.

With reference to MIHAN SEZ, Development Commissioner suggested that it is the Developers' responsibility to go to world players & promote SEZ to the various companies. MADDC needs to project MIHAN as an investment junction that can be developed into an export and logistic hub.

1. Representative from M/s. Infocept appreciated the cooperative environment in MIHAN and the talent pool for IT. However they emphasized on faster clearance from customs.
2. Representative from Hexaware BPS informed that DC Office at Nagpur should facilitate to solve small issues in MIHAN
3. Representative from M/s. SP Infocity informed that as a Co-Developer of an IT Park, they are not receiving positive response from IT companies in Nagpur.
4. Shri. Charde from Water Care Technologies expressed his gratitude towards MADDC for their support in acquiring office in CFB, MIHAN
5. The doubts raised by Elhousie German regarding the process of applying for LoP were cleared by Development Commissioner
6. Shri. Vipul Yellewar from White Space Venture and Shri. Ashish Jagrawat from Moon SEZ expressed their concerns over SEZ policies.
7. Representative from M/s. Lupin expressed their concern over the long gestation period in SEZ and Income Tax/ sunset clause by year 2017 along with the Security of SEZ. He asked if Excise duty benefits in DTA could be given to units.
8. Shri. Shukla gave inputs on the SEZ act and emphasized on hassle free custom procedure
9. Representative from Murodiya Consultancy Services suggested to appoint a Nodal Officer at DC office MIHAN

Development Commissioner suggested that Nodal Officer's name of MIHAN may be placed on DC Website. He clarified that Authorized officer is not a customs officer but is an Authorized officer working under Development Commissioner. He is also contact point for DC Office for the units/co-developers. Development Commissioner clarified that Authorized officer is not allowed to issue notice without permission of DC. No offence is an offence in SEZ unless notified under the SEZ Act
