**(I) Procedure for submission of tender is as follows :**

1. The tender shall be awarded for a period from **15<sup>th</sup> June 2016 to 31<sup>st</sup> August 2016.**

2. The envelope containing quotation shall be superscribed as **SEEPZ SEZ Tender for disposal of non-hazardous solid waste.** The envelope shall clearly indicate the name of the Agency.

3. The envelope shall contain the following :

- a. Financial quotation shall indicate rate per KG offered for each item separately as indicated above. However, the award will be on the basis of total value calculated on the basis of weighted average garbage of last 3 months.
  - b. Demand Draft of Rs. 1,00,000/- (Rs. One Lac only) in favour of SEEPZ SEZ Authority Fund towards Earnest Money Deposit.
  - c. Self certified copies of PAN & TIN.
4. Failure to comply with the aforesaid conditions shall be liable for rejection of quotation by the Tender Committee.

**(II) Opening of Quotations :**

**The last date for submission of quotation is 15.06.2016 till 4.00 p.m.** The sealed quotations shall be opened by the Tender Committee on the same date at 5.00 p.m. in the conference hall of the Office of the Development Commissioner in presence of bidders and or their representative.

**(III) Terms of Contract :**

1. The awardee shall deposit Rs. 1,00,000 (Rs. One Lac only) within 3 days of awarding of contract.
2. Once the deposited amount of Rs. 1,00,000/- (Rs. One Lac only) is exhausted, advance shall be deposited by the awardee for subsequent lifting of garbage.

3. VAT and TCS shall be charged extra.
4. The garbage shall be lifted atleast once in every three days.
5. The quantity of garbage shall be lifted in such a way that the kachra kundi remains clean. No garbage shall be accumulated near the dump area.
6. In case the contractor fails to lift the garbage once in three days he shall be liable for a fine of Rs. 5000/- (Rs. Five Thousand only) and if the garbage is not lifted for more than seven days the contract shall be terminated and will be given to the next bidder without calling any fresh quotations.
