Agenda Item No. 1:- Confirmation of Minutes of the Meeting held on 07.02.2014.

The minutes of the 19th Meeting held 07.02.2014 on were confirmed.

Agenda Item No. 2:- Approval of list of goods for Authorized Operations - M/s. Wockhardt Infrastructure Development Limited (Developer).

The representative of the unit stated that as regards approval of the Planning Authority, they have submitted the necessary documents and applications to the MIDC vide their application dated 3rd December, 2014. He further stated that as per Rule 7.4 of the MIDC Rules,

"If within sixty days receipt of the notice, the chief Executive Officer fails to intimate in writing to the person who was given the notice his refusal or sanction with or without modifications or direction, the notice with its plans and statements shall be deemed to have been sanctioned, provided that this shall not

be constructed to authorize any person to do, anything on the site of the work in contravention of or against the terms of lease or titles of the land, or, against these or any other regulations, bye - laws ordinance or ordinance operating on the site of the work, provided that, the development proposal, for which the permission was applied for, is strictly in conformity with the requirements of all the relevant Development Control Regulations framed under MR & TP Act or bye-laws or regulations framed in this behalf under any law for the time being in force and the same in no way violates either the provisions of any draft or final plan or proposals published by means or notice submitted for sanction under the MR & TP Act.

Provided further that, any development carried out in pursuance of such deemed permission which is in contraventions of the provisions of the first proviso, shall be deemed to be an unauthorized development for the purpose of sections 52 to 57 of MR & TP Act."

He further said that the approval of list of goods is urgently required as they propose to commence construction activities expeditiously.

After detailed discussion, the Committee approved the proposal of M/s. Wockhardt Infrastructure Development Ltd. (Developer) for list of goods for unit-3 (OSD Block) & Canteen facility at an estimated cost of Rs. 13,440.80 Lacs in view of the aforesaid deemed approval provision in the MIDC Rules.
