Agenda Item No. 2:- Request of M/s. Arshiya Limited, for inclusion of the Addition of list of Goods.

M/s. Arshiya Limited, have been issued Letter of Approval No. SEEPZ/NEWSEZ/Arshiya-Raigad/105/LOA-98/2013-14/13721, dated 05.12.2013 for warehousing and trading activities. The unit has requested for inclusion of the additional list of Goods to their LOA vide letter dated 20.05.2014. The committee rejected the proposal and asked the unit to resubmit the list of required goods along with project report for each item/goods. The unit resubmitted the application dated 29.07.2014.
